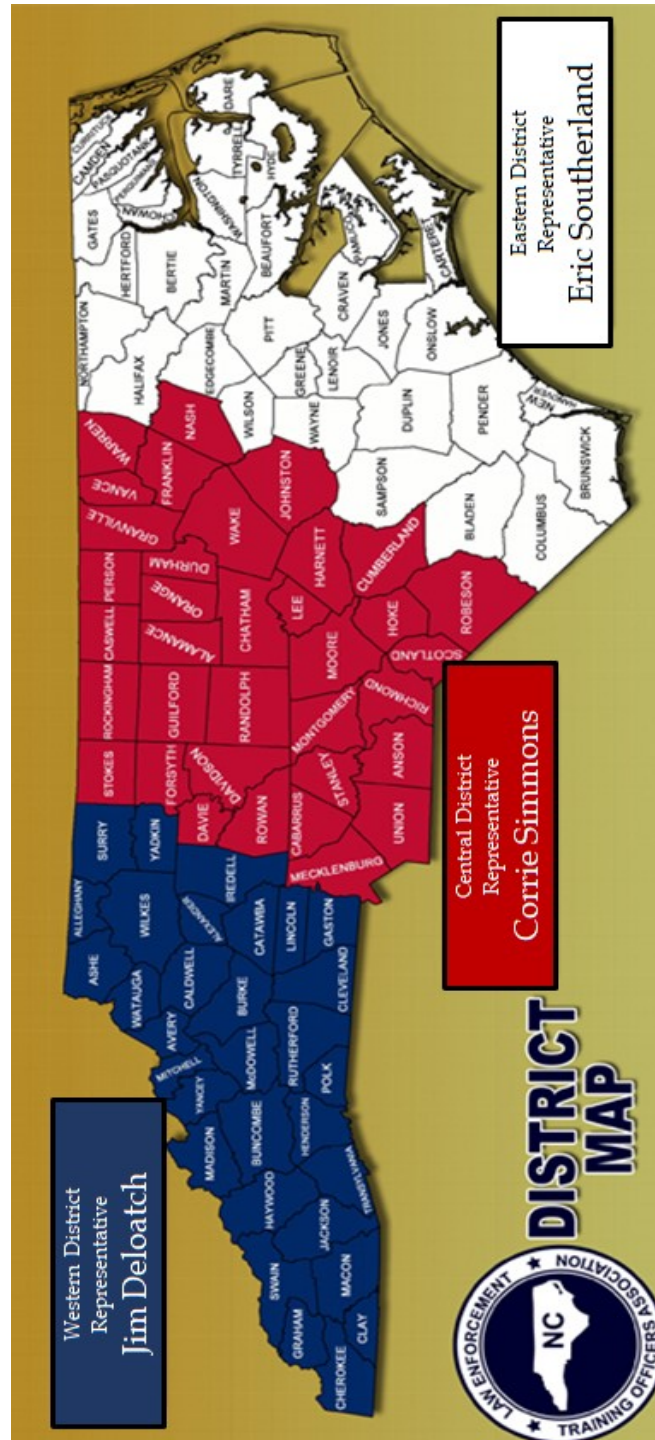


Association objectives:
